** Modules from all three specialization areas can be mixed. Your specialization will be shown on your final certificate if you have completed at least 18 CP within one specialization, i.e. Political Economy, Sustainability or Money, Accounting, and Finance.

Excerpt from **§ 23 Master Thesis**: Admission to the Master thesis requires successful completion of the area „Foundations“ (24 CP) and at least 18 CP in the area „Institutions and Behaviour: Theory“ and „Institutions and Behaviour: Empirics“.

Excerpt from **§ 30 Repetition of examinations**: “(1) Passed examinations cannot be repeated. (2) Failed examinations may be repeated twice. (3) It is permissible to change up to two elective modules that have been definitively failed once.”

A **module commitment**, i.e. the obligation to complete a module that has been started, exists as soon as an examination attempt has been failed. You can recognise this by the fact that the status of your module is shown as ‘Coursework submitted/registered’. You then must complete a module unless you are willing to declare it failed according to §30 (3) (see above).

There is no module commitment (status of the module is ‘existing entry’) in the following cases: (1) Only course bookings have been made so far, no examination registrations. (2) In contrast to examinations, ungraded assignments, whether passed or failed, do not yet trigger a module commitment. (3) Withdrawal from the examination has been recognised (note ‘AT’ for doctor’s certificate).
